Section 4: First aid measures

4.1 Description of first aid measures

Skin contact: wash the contaminated skin thoroughly with plenty of water with soap. Consult a doctor if disturbing symptoms appear.

Eye contact: remove contact lenses. Wash the contaminated eyes with plenty of water for 15 minutes. Avoid powerful water stream – risk of cornea damage. Consult a doctor if disturbing symptoms appear.

Ingestion: exposure by this route does not typically occur. If swallowed, do not induce vomiting. Rinse mouth with water. Never give anything by mouth to an unconscious person. Consult a doctor, show container or label.

Inhalation: remove the victim to fresh air. Keep warm and calm. Consult a doctor, if disturbing symptoms occur.

4.2 Most important symptoms and effects, both acute and delayed

Negative effects of exposure during the normal and intended use of the product are not expected.

4.3 Indication of any immediate medical attention and special treatment needed

Physician makes a decision regarding further medical treatment after thoroughly examination of the injured. Treat symptomatically.

Section 5: Firefighting measures

5.1 Extinguishing media

Suitable extinguishing media: adapt the extinguishing media to surrounding materials.

Unsuitable extinguishing media: water jet – risk of the propagation of the flame.

5.2 Special hazards arising from the substance or mixture

During the fire, the product may produce harmful fumes of carbon oxides, nitrogen oxides or other unidentified thermal decomposition products. Do not inhale combustion products, they can be dangerous for human health.

5.3 Advice for firefighters

Personal protection typical in case of fire. Do not stay in the fire zone without self-contained breathing apparatus and protective clothing resistant to chemicals. 6.3 Methods and material for containment and cleaning up

7.1 Precautions for safe handling
