Section 4: First aid measures

4.1 Description of first aid measures

<u>Skin contact:</u> take off contaminated clothes and wash it before reuse. Wash contaminated skin thoroughly with water and soap. Consult a doctor if disturbing symptoms occur.

<u>Eye contact:</u> remove contact lenses. Rinse contaminated eyes with water for a few minutes. Avoid strong stream of water – risk of damage of the cornea. Contact an ophthalmologist if disturbing symptoms occur.

<u>Ingestion:</u> do not induce vomiting. Rinse mouth with water. Never give anything by mouth to an unconscious person. Consult a doctor if disturbing symptoms occur.

Inhalation: remove the victim to fresh air. Keep warm and calm. Consult a doctor, if disturbing symptoms occur.

4.2 Most important symptoms and effects, both acute and delayed

Skin contact: possible redness, dryness, skin cracking, defatting.

Eye contact: possible redness, tearing, burning sensation.

Ingestion: possible abdominal pains, nausea, vomiting, diarrhoea.

<u>Inhalation:</u> high concentration of vapours may cause irritation of mucous membranes of eyes and respiratory tract.



4.3 Indication of any immediate medical attention and special treatment needed

Physician makes a decision regarding further medical treatment after thoroughly examination of the injured. Symptomatic treatment.

Section 5: Firefighting measures

5.1 Extinguishing media

<u>Suitable extinguishing media:</u> extinguishing powder, alcohol resistant extinguishing foam, carbon dioxide, water spray. Adjust extinguishing media to the materials stored in the product vicinity.

<u>Unsuitable extinguishing media:</u> water jet – risk of propagation of flame.

5.2 Special hazards arising from the substance or mixture

During combustion harmful gases consisting of carbon oxides and other unidentified products of thermal decomposition may be produced. Do not inhale combustion products, it may cause health risk.

5.3 Advice for firefighters

Personal protection typical in case of fire. Do not stay in the fire zone without self-contained breathing apparatus and protective clothing resistant to chemicals. In case of fire cool endangered containers with water spray from the safe distance. Do not let extinguishing water to reach drainage system, ground and surface waters.

Section 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

Limit the access for the outsiders into the breakdown area, until the suitable cleaning operations are completed. Ensure that removing the problem and its results is conducted by a trained personnel only. In case of large spills, isolate the exposed area. Avoid eyes and skin contamination. Do not inhale product vapours. Ensure adequate ventilation. Wear adequate personal protective equipment.

6.2 Environmental precautions

In case of release of large amounts of the product, it is necessary to take appropriate steps to prevent it from spreading into the environment. Notify relevant emergency services.

6.3 Methods and material for containment and cleaning up

Put damaged container in a tight protective container. Collect product using liquid binding materials (eg. sand, earth, universal binding substances, silica, vermiculite etc.) and place it in correctly labelled containers. Treat collected material as waste. Clean residues using water with mild detergent and ventilate contaminated place.

Section 7: Handling and storage

7.1 Precautions for safe handling

Handle in accordance with good occupational hygiene and safety practices. Do not eat, drink or smoke during work. Wear personal protective equipment. Avoid eyes and skin contamination. Do not inhale product vapours. Ensue adequate ventillation. Wash hands before breaks and after work. Keep unused containers thigtly sealed.

7.2 Conditions for safe storage, including any incompatibilities

Store only in original, tightly closed containers in a dry, cool and well ventilated place. Keep away from food, foodstuffs, animal feed and incompatible materials (see subsection 10.5). Opened container should be resealed and stored upright to prevent leakage. Store away from sources of ignition and direct sunlight. Kept from frost. Recommended storage temperature: below 40°C.

8.2 Exposure controls
