Section 4: First aid measures

4.1 Description of first aid measures

<u>Skin contact:</u> wash contaminated skin thoroughly with water and soap for at least 15 min. Take off contaminated clothes and wash it before reuse. Consult a doctor if disturbing symptoms occur.

<u>Eye contact:</u> remove contact lenses. Rinse contaminated eyes with water for at least 15 minutes. Avoid strong stream of water – risk of damage of the cornea. Contact an ophthalmologist if disturbing symptoms occur.

<u>Ingestion:</u> do not induce vomiting. Rinse mouth with water. Never give anything by mouth to an unconscious person. Call doctor immediately, show container or label.

<u>Inhalation:</u> remove the victim to fresh air. Keep warm and calm. Consult a doctor, if disturbing symptoms occur.

4.2 Most important symptoms and effects, both acute and delayed

Negative effects of exposure during the normal and intended use of the product are not expected.

4.3 Indication of any immediate medical attention and special treatment needed

Physician makes a decision regarding further medical treatment after thoroughly examination of the injured.

Section 5: Firefighting measures

5.1 Extinguishing media

<u>Suitable extinguishing media:</u> extinguishing powder, alcohol resistant foam, carbon dioxide, water spray. Adjust extinguishing media to the materials stored in the product vicinity.

<u>Unsuitable extinguishing media:</u> water jet – risk of propagation of flame.

5.2 Special hazards arising from the substance or mixture

During combustion harmful gases consisting of carbon oxides, nitrogen oxides may be produced. Do not inhale combustion products, it may cause health risk.

5.3 Advice for firefighters

Personal protection typical in case of fire. Do not stay in the fire zone without self-contained breathing apparatus and protective clothing resistant to chemicals. In case of fire cool endangered containers with water spray from the safe distance. Do not let extinguishing water to reach drainage system, ground and surface waters.

6.1 Personal precautions, protective equipment and emergency procedures

Limit the access for the outsiders into the breakdown area, until the suitable cleaning operations are completed. Ensure that removing the problem and its results is conducted by a trained personnel only. In case of large spills, isolate the exposed area. Avoid eyes and skin contamination. Ensure adequate ventilation. Do not inhale product's vapours. Wear adequate personal protective equipment.

6.3 Methods and material for containment and cleaning up

Put damaged container in a tight protective container. Absorb the leakage with liquid-binding material (e.g. sand, earth, vermiculite, universal binding agents, silica etc.) and transfer to appropriate waste containers. Treat the collected material as waste. Rinse off the residues with water and mild detergent. Ventilate the contaminated surface.

Section 7: Handling and storage

7.1 Precautions for safe handling

Handle in accordance with good occupational hygiene and safety practices. Do not eat, drink or smoke during work. Wear personal protective equipment. Avoid eyes and skin contamination. Do not inhale product's vapours. Ensure adequate ventillation. Wash hands before breaks and after work. Keep unused containers thigtly sealed. Protect from moisture and high temperature. Work away from sources of fire.

Store only in original, tightly sealed containers in a dry, cool and well-ventilated area. Store away from food and feed for animals. Opened container should be resealed and stored upright to prevent leakage. Keep away from sources of ignition and direct sunlight.

8.2 Exposure controls
